ARTICLES OF MEMBERSHIP

ELIGIBILITY. Membership in ASEDA SHALL BE OPEN TO ANY PERSON 16 YEARS OF AGE OR MORE UPON PAYMENT OF ANNUAL DUES.

Classes. There shall be three classes of membership, as follows: single membership, student membership, and family membership.

(a) Single Membership: any person, age 16 or older, who is not a student or family member. (b) Student Membership: any person, age 16 or older presenting a valid student ID.

(c) Family Membership: two individuals 16 or older and their family, residing at the same address..

MEMBERSHIP DURATION. Membership duration shall be one year starting from the month the dues are received by ASEDA.

MEMBERSHIP DUES & FEES. Membership dues and fees shall be set by two-thirds (2/3) majority vote of the Board of Directors each year.

MEMBERSHIP RECORDS. The following records of ASEDA membership shall be maintained: (a) an up-to-date listing of the name, street address, e-mail address and telephone numbers of each member; (b) class of membership, date and amount of dues paid.

MEMBERSHIP RIGHTS. Each member shall be entitled to: (a) discounts to ASEDA-sponsored events; (b) a copy of the newsletter (provided that only one will be sent to a household having a family membership); (c) an up-to-date copy of the ASEDA Bylaws upon request; (d) a copy of the minutes of all meetings of the Board of Directors upon request; (e) access to inspect ASEDA financial records, books, or minutes of preceding meetings upon written request and within a reasonable period of time as specified by the Board of Directors.; (f) vote in all general membership elections, including election of the Board of Directors; (g) nominate themselves or another member to run for a position on the Board of Directors at the annual elections; and (h) request a Special Member Meeting as described in the Bylaws.

TRANSFER OF MEMBERSHIP. ASEDA Memberships are not transferable with other people or other swing dance societies.

TERMINATION OF MEMBERSHIP. The Board of Directors, by an affirmative vote of two-thirds (2/3) of the Board members, may suspend or expel any member for good cause after a right to a hearing before the BOARD to which the member is given at least on week's written notice. Any member suspended or expelled from ASEDA shall not be allowed to participate in any ASEDA sponsored activities as a non-member guest.

RESIGNATION. Any member may resign his or her membership by filing a written resignation with the Board of Directors. Such resignation shall not relieve the member of the obligation of paying accrued but unpaid dues, assessments, fees or other charges. Membership fees that have been paid are not refundable.
